

ASSUMPTION OF RISK AND RELEASE AGREEMENT

Read carefully before signing

This assumption of Risk and Release agreement is executed on this _____ day of _____, 2015, by the undersigned, _____, being eighteen years of age or older, whose address is _____, (as “releaser”), and the Historic Fort Wayne Coalition (as “Release’s”).

In consideration of being allowed to enter upon the property and participate in the 2015 Flea Market & Collectables Show, in and about Historic Fort Wayne Detroit Michigan, and being aware of the risks and hazards inherent upon entering upon said premises and participation the said event, I hereby elect to voluntarily enter upon said premises, knowing their present condition and knowing that said condition may become more hazardous and dangerous during the time that I voluntarily enter upon the premises and participate in the event, and with full knowledge that such participation will (a) involve possible trip and fall hazards (b) involve the close proximity to hazards materials such as lead paint etc. (c) possible hazards material falling within close proximity to myself and being fully aware of the dangers present in these areas and the close proximity to the stated dangers, the undersigned, for myself, my spouse, heirs, legal representatives, and assigns, assumes all risks of loss, damage or injury, including death that may occur to, and be sustained by me, while in or upon said premises and as a participant in the 2015 Flea Market & Collectables Show On April 25th and 26th 2015, in and about Historic Fort Wayne Detroit, Michigan.

In consideration of the above, the undersigned, for myself, my spouse, heirs and legal representatives, and assigns, hereby release, discharges, and holds harmless the Releases, and their respective officers, commissioners, employees, agents, executors, and assigns, and all other persons, firms, corporations, and units of government involved in sponsoring and / or hosting this drill, from any and all claims, demands, rights, causes of loss or damage to property, present and future, and the consequences thereof resulting from my participation in the Flea Market & Collectables Show on April 25th and 26th 2015 in and about Historic Fort Wayne Detroit, Michigan.

I also agree that while participating in the 2015, Flea Market & Collectables Show, I shall abide by and be bound by all orders rules and regulations of the sponsors and hosts of the Event.

This Assumption of Risk and Release Agreement contains the entire agreement between the parties herein named and the terms of this release are contractual and not mere recital. I expressly agree that this Assumption of Risk and Release is intended to be as broad and inclusive as permitted by the laws of the State of Michigan and that if any portion thereof is held invalid, the balance shall, notwithstanding, continue in full force and effect. I further state that I have carefully read the foregoing Assumption of Risk and Release Agreement and know the contents thereof, and I sign the same as my free act.
